Explanation of Scorecard

S = A vote in support of our position **O** = A vote opposed to our position
Green Bill Title = A bill we supported **Red Bill Title** = A bill we opposed
Bill titles reflect a layman's description of the legislation, not their official titles

Parental Rights – SB190 – An act to protect a parents ability to direct the upbringing, education, and medical decisions of their child and apply “strict scrutiny” to government actions that would infringe on parental rights.

Medical Ethics – HB1153 – An act to protect the conscience rights of medical providers and preserve their ability to “do no harm”

Scholarship Eligibility – SB84 – An act to expand the student eligibility and scholarship granting ability for the Partners in Education Scholarship Program

Religious Harassment – SB113 – An act to increase the penalty for prohibiting a person from practicing their religion through the use of threats or violence

Mandatory Reporters – HB1216 – An act to add clergy to the list of mandatory reporters and remove religious privilege in judicial proceedings

Sports Betting – SJR504 – A measure to place on the ballot the question of mobile sports betting

Video Lottery – SB226 – An act to increase the video lottery bet limit and the number of machines allowed per establishment

Define Man/Woman – HB1184 – An act to provide clear definitions of male and female, based on biological realities, to be used thorough out state code

Age Verification – HB1275 – An act to require age verification at the app store level before signing a digital agreement and require accurate age ratings of applications

Privacy Protections - HB1161 – An act to remove privacy protections for firefighters, law enforcement personnel, theatre performers, and musicians *Note: After the failure of HB1161, the stakeholders worked with our team to craft a “hohouse” that was amenable to all sides.*

Birth Centers – HB117 – An act to allow Certified Professional Midwives to supervise birth centers and remove the 30-minute travel requirement

Embryo Reporting – HB1182 – A act to require healthcare institutions to report the number of embryos created, destroyed, or successfully implanted

Criminal Penalties – HB1212 – An act to apply criminal penalties to a post-abortive mother

Abortion Pills – HB1274 – An act to prohibit the distribution, sale, or advertising of abortion pills

Fetal Development – HB1313 – An act to require that videos and other materials be included in public school curriculum that clearly illustrate the development of a baby inside the womb

Miscarriage – HB1257 – An act to provide further clarity that South Dakota's abortion laws do not prohibit treatment for miscarriage or ectopic pregnancy
